## BOARD MEETING January 4, 1886 Court House

Be it remembered that the Board of Mayor and Aldermen for Town of Dyersburg met in regular session on Monday night January 4, 1886 at Court House.

Present and presiding Mayor Thomas – Aldermen Watkins, Smith, Jones, Tenney, Turner, Hayes and Marshal J. P. Thurmond.

Minutes of last meeting read, approved and signed.

On motion on alleys fixed up was discharged for present.

On motion it was ordered that the old ordinances in force under the old charter are hereby declared in full force and adopted under the new charter.

On motion it was ordered that a fine of \$50.00 be put on any party found guilty of building any frame or wooden structure within 120 feet of the public square and that it be the Marshal's duty to tear the same down when discovered.

On motion Marshal J. P. Thurmond was allowed a salary of three hundred dollars for year 1885 and the same ordered placed to his credit on settlement confirmed by the Board January 4, 1886.

On motion the Marshal was ordered to pay over to the Treasurer of Dyersburg the amount of funds shown by settlement to be in his hands – to wit:

Corporate fund \$203.44, School Fund \$606.48.
