## Recorder's Bond

Know all men by these presents that We, W. R. Hayes principal and J. H. Baker and Z. G. Watkins securities are held and firmly bound unto the Mayor and Aldermen of the Town of Dyersburg, Tennessee in the plural sum of one thousand dollars for the payment of which we bind ourselves, our heirs, representatives and administrators jointly and severally firmly by these presents, but the condition of the above bond is such that whereas the above bound W. R. Hayes has been elected Recorder of the Town of Dyersburg, Tennessee for the years 1886 and 1887. Now, therefore, should the said W. R. Hayes faithfully discharge the duties of said office and fully and truly account for and pay over as may be required by law and by the Board all funds of the Corporation that may come into his hands and to faithfully discharge all other duties required by him by law or by the Board – then and in that event this bond to be null and void, otherwise to remain in full force and effect.

## **Treasurer's Bond**
