Board of Mayor and Aldermen Meeting Monday, January 5, 2015 Dyersburg Municipal Court Room

- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, January 5, 2015 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided.
