# Board of Mayor and Aldermen Meeting Tuesday, September 21, 2015 Dyersburg Municipal Court Room

- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, September 21, 2015 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor Holden presided over the meeting. The meeting opened with prayer by Alderman Robert Taylor, Jr. Mayor Holden noted all Aldermen were present. Boy Scout Throop #87 was present for the meeting to earn credits toward merit badges, and Boy Scout Luke Schrader led the courtroom in the Pledge of Allegiance.
- (2) <u>Approval of Minutes:</u> The minutes of the September 8, 2015 meeting were approved on a motion by Alderwoman Carolyn Norman, followed by a second from Alderman Robert Taylor, Jr.. The motion passed approving the minutes.
- Operations presented a request for the Board to participate in a 10 year Interlocal Cooperation Agreement with the Dyer County Emergency Communications District, providing 911 services. The agreement was ratified by a motion for approval from Alderman Bob Kirk, with a second by Alderman Bill Escue. The motion passed by full Board approval.

- d. Notice of Public Hearings September 21, 2015.
- 1. Ordinance amending Title 8, Chapter 2 for Dyersburg Municipal Code, entitled Beer, Section 8-205, entitled Inference with Public Health, Safety, and Morals Prohibited. Mayor Holden announced the call for a public hearing regarding amending the current beer ordinance by deleting the term "private residence" in the third paragraph from the language of the ordinance. Other than the revised language, Section 8-205 is hereby re-adopted in its entirety. This amendment was first noticed at the August 17, 2015 Mayor and Alderman Board meeting. Such Public Hearing was advertised in the State Gazette newspaper on September 2, 2015. It was noted the Public Safety Committee approved the recommendation for the amendment to the full board from their meeting held August 12, 2015.

No statement was presented by the general public at the meeting. Mayor Holden asked for a motion regarding the approval of the amendment as presented before the Board. Alderman Bob Kirk motioned for the approval of the amendment, followed by a second from Alderman Mike Morgan. The motion was

approved by full Board vote, with the exception of Mayor Holden voting "no" to the motion.

# 2. Adoption of 2015 International Residential Building Code with revisions and the 2009 International Energy Conservation Code.

Mayor Holden announced the call for a public hearing regarding for adoption by the City of the 2015 Residential Building Codes and the 2009 Energy Codes, as noticed in the State Gazette newspaper, and at the meeting of September 8, 2015 Board of Mayor and Aldermen.

# **ORDINANCE NO. 642**

AN ORDINANCE of the CITY OF DYERSBURG adopting the 2015 edition of the *International Residential Code*, regulating and governing the construction, alteration, movement, enlargement, replacement, repair, equipment, location, removal and demolition of detached one- and two-family dwellings and multiple single-family dwellings (townhouses) not more than three stories in height with separate means of egress in the CITY OF DYERSBURG; providing for the issuance of permits and collection of fees therefor; repealing the referenced 2006 International Residential Code, known as an associated code, within ORDINANCE No. BB-605 of the CITY OF DYERSBURG and all other ordinances or parts of laws in conflict therewith.

# The BOARD OF MAYOR AND ALDERMEN of the CITY OF DYERSBURG does ordain as follows:

Section 1. That a certain document, three (3) copies of which are on file in the office of the DYERSBURG CODE ENFORCEMENT of CITY OF DYERSBURG, being marked and designated as the *International Residential Code*, 2015 edition, including Appendix Chapters A, B, C, D, E, G, H, J, N, P, as published by the International Code Council, be and is hereby adopted as the Residential Code of the CITY OF DYERSBURG, in the State of TENNESSEE for regulating and governing the construction, alteration, movement, enlargement, replacement, repair, equipment, location, removal and demolition of detached one- and two-family dwellings and multiple single-family dwellings (townhouses) not more than three stories in height with separate means of egress as herein provided; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions and terms of said Residential Code on file in the office of the DYERSBURG CODE ENFORCEMENT are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 2 of this ordinance.

## **Section 2.** The following sections are hereby revised:

Chapter 3, Section R313, Automatic Fire Sprinkler Systems (Removed) per State of Tennessee Legislation TCA 68-120-101 (8)

Chapter 11, Energy Efficiency, (Removed) Replaced with 2009 International Energy Conservation Code

Chapter 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, Electrical (Removed) State Adopted Electrical Code shall apply

**Section 3.** The **2006 INTERNATIONAL RESIDENTIAL CODE** and all other ordinances or parts of laws in conflict herewith are hereby repealed.

**Section 4.** That if any section, subsection, sentence, clause or phrase of this legislation is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The **CITY OF DYERSBURG** hereby declares that it would have passed this law, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

**Section 5.** That nothing in this legislation or in the Residential Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this law; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this legislation.

**Section 6.** That the **CITY OF DYERSBURG RECORDER** is hereby ordered and directed to cause this legislation to be published.

**Section 7.** That this law and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect **JANUARY 1, 2016.** First reading: 17th day of August, 2015.

# Ordinance NO. 643

An ordinance of the **City of Dyersburg** adopting the 2009 edition of the *International Energy Conservation Code*, regulating and governing energy efficient building envelopes and installation of energy efficient mechanical, lighting and power systems in the **City of Dyersburg**; providing for the issuance of permits and collection of fees therefor; repealing the referenced 2006 International Energy Conservation Code, known as an associated code, within Ordinance No. BB-605 of the **City of Dyersburg** and all other ordinances and parts of the ordinances in conflict therewith.

The Board of Mayor and Aldermen of the **City of Dyersburg** does ordain as follows:

Section 1. That a certain document, three (3) copies of which are on file in the office of the Dyersburg Code Enforcement of City of Dyersburg, being marked and designated as the International Energy Conservation Code, 2009 edition, as published by the International Code Council, be and is hereby adopted as the Energy Conservation Code of the City of Dyersburg, in the State of Tennessee for regulating and governing energy efficient building envelopes and installation of energy efficient mechanical, lighting and power systems as herein provided; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions and terms of said Energy Conservation Code on file in the office of the City of Dyersburg are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 2 of this ordinance.

**Section 2**. The following sections are hereby revised: Any additions, insertions, deletions and or changes of the 2009 International Energy Conservation Code adopted by the State of Tennessee shall apply.

**Section 3**. The **2006 International Energy Conservation** Code and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

**Section 4**. That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The **City of Dyersburg** hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

**Section 5**. That nothing in this ordinance or in the Energy Conservation Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this legislation.

**Section 6**. That the **City of Dyersburg Recorder** is hereby ordered and directed to cause this ordinance to be published.

**Section 7**. That this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect January 1, 2016.

**Aldermen Bob Kirk:** Asked Alderman Moody about the future continuation of the TVA Fuel Charge to customers. Alderman Moody informed the Board that the charge would probably continue. The charge originates from TVA and the cost is determined from month to month by TVA.

Alderman Bill Escue: No report.

Alderman Terry Glover: No report.

**Alderman Kevin Chaney:** Informed the Board of a recent telephone call requesting a white dividing line to be extended to the middle school on Millsfield Highway. Also, a request for limbs to be trimmed on McArthur Street.

Alderman Mike Morgan: No report.

**Alderman Dennis Moody:** Questioned an inordinate number of continuous yard sales in the City. Mayor Holden stated that each residence was allowed one permit every six months.

Alderwoman Carolyn Norman: No report.

Alderman Robert Taylor Jr.: Expressed concerns over some items not being picked up at curbside, excessive number of stray cats, and kids throwing rocks on Forrest Street. Mayor Holden responded by stating that the Sanitation department had been instructed to follow the specific ordinance for curbside pickup. The rock throwing complaints should be reported to the Dyersburg Police Department. The Dyersburg/Dyer County Humane Society may have live traps available for cats, as they do not capture stray cats, only dogs.
